- C&S Management Issues
 - Frequent errors by community management company continue.
 - Several other Management companies have been contacted.
 - Several have not responded
 - <u>Associa Gulf Coast</u> has submitted a Draft Proposal which as written, could lead to higher cost. Further investigation needed.
 - Going alone without a Management company will be investigated as well.
- Swale and Preserve Policy
 - SWFWMD (Southwest Florida Water Management District) requires permit and inspection: Proper maintenance of Swales, and Detention Ponds are required.
 - Policy Guidelines were sent to all Homeowners. Plan to vote on policy at next BOD meeting.
 - Records with SWFWMD are revised to show NRE Community Association as owner.

- Current Landscaping Contract is under review.
